Las Flores was established in 1976. The campus includes eleven portable classrooms, arranged to facilitate individual and group instruction. We have a computer lab with 21 computers, a library that also serves as a career and testing center, and a mini gym. We are proud of our campus and strive to keep our school in good repair so it is a clean, safe, and functional environment for teaching and learning. Monthly inspections are conducted by our lead custodian.

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority.
