We believe that nothing should get in the way of the academic achievement of our students, which is why it is important that our students feel safe. An "Emergency Handbook", outlining a plan of action for emergencies such as earthquakes, fires, floods, and chemical spills, is kept in the school office. Security staff also monitor all after school events, such as games and dances.

Our Special Education services include not only special education students, but also general education students who need additional support to meet the standards. Gifted and Talented students participate in Honors and Advanced Placement courses. The Design and Technology Academy was awarded a California Partnership Grant in October of 2008.

XII. Instructional Planning and Scheduling

Professional Development

This section provides information on the annual number of school days dedicated to staff development for the most recent three-year period.

Our school and district offer a variety of professional learning opportunities for teachers, instructional aides, and non-instructional support staff. Through our district's Trainer of Trainers program, four times per year a team of teachers attends training on research-based teaching practices and returns to the site and shares the information they learned with the whole staff. In addition, our school has a weekly early release Thursday schedule in which students leave school one hour early. Teachers use this time to meet in teams to review student work, plan curriculum and improve instructional practice.

New teachers who have been teaching fewer than two years are supported by the district's beginning teacher program (BTSA). They meet weekly with an experienced mentor to discuss their successes and challenges and new ideas for their classrooms.

Finally, the district offers a variety of classes for support staff. Instructional aides, school secretaries, office clerks, and custodians may take classes that relate to their work such as learning new computer skills and learning to work more efficiently and in ergonomically correct ways.
