INSTRUCTIONS FOR EGUSD MELLO-ROOS TAX REDUCTION APPLICATION

FILING PERIOD: The filing period each year is APRIL 15 to JUNE 30

You must have a completed application filed by **June 30**th to initiate the first year's reduction. After the first year's reduction, a courtesy reminder renewal notice will be mailed to the address on file.

RETROACTIVE REDUCTIONS DO NOT APPLY. This reduction will be *effective* **July 1**st through **June 30**th (for the upcoming tax year). In order to continue to receive the 70% EGUSD Mello-Roos Tax Reduction for **direct levy #0155**

YOU MUST RENEW YOUR STATUS EACH YEAR DURING THE FILING PERIOD

APPLICATION PROCESS

- **1. COMPLETE THE APPLICATION** (only one applicant per household)
- 2. INCLUDE A COPY OF YOUR QUALIFYING DOCUMENTATION

You must provide a qualifying documentation that the applicant is 65 years or older OR is blind/disabled. Only ONE (1) of the following is required.

65 years of age or older:

- Driver's License / Identification Card
- Birth Certificate
- Medicare Card

Blind/Disabled:

- Social Security Disability Award Letter
- Supplemental Security Income Letter
- Statement of Permanent Disability signed by your Physician

A COPY OF THE QUALIFYING DOCUMENTATION MUST BE ATTACHED TO THE COMPLETED APPLICATION

70% REDUCTION ONLY APPLIES TO DIRECT LEVY #0155 OF YOUR PROPERTY TAX BILL (ELK GROVE UNIFIED SCHOOL DISTRICT CFD NO. 1 "MELLO-ROOS" TAX)

THE REDUCTION CAN ONLY BE APPLIED TO THE APPLICANT'S PRIMARY RESIDENCE ALL OTHER PROPERTIES ARE SUBJECT TO THE FULL TAX

ONLY ONE APPLICANT PER HOUSEHOLD CAN APPLY FOR THE EGUSD MELLO-ROOS TAX REDUCTION

The tax reduction pertains to the property tax that is levied on the LAND. Ownership would indicate that the land is owned; ownership of only a mobile home does not constitute land ownership. If the land on which the applicant lives is rented/leased, then the owner of the land must fill out the bottom portion of the application.

SCHOOL AGE CHILDREN - There must not have been any school-age children living in the residence for the 24 months prior to the June 30th deadline. If school-age children have lived in the residence within those 24 months, the applicant does not qualify for the reduction.

AGE 65 OR OLDER - Applicants must be 65 years old by June 30th of the current year to be eligible for the reduction.

BLIND/DISABLED - A disabled person is defined as "an individual who is unable to engage in any substantial, gainful activity by reason of any medically determinable physical or mental impairment that can be expected to last for a continuous period of not less than twelve months." Further, you shall be determined to be "disabled" only if the physical or mental impairments are of such severity that you are not only unable to do your previous type of work, but cannot (considering age, education, and work experience) engage in any kind of substantial gainful work.

The application along with the qualifying documentation shall be submitted to the Elk Grove Unified School District, Facilities and Planning office by **June 30**th.
